To Whom It May Concern:

As the director of one of America's most successful licensed long-term substance abuse rehabilitation programs I am always looking for innovative methods to help people. For over 42 years Habilitat has achieved the highest levels of success by using a no-nonsense approach and by being willing to try non-traditional techniques.
